Call to Order, Invocation, and Pledge of Allegiance.

Speakers are limited to 3 minutes. In accordance with the Texas Open Meetings Act, the City Council cannot act on items not listed on the agenda. - 2021-412 Conduct a public hearing regarding the proposed FY 2021-2022 Annual Operating Budgets for the City of Midlothian.
- 2021-413 Conduct a public hearing regarding the proposed FY 2021-2022 tax rate, and schedule and announce the date, time and place of the meeting to adopt the tax rate

- 2021-417 Consider and act upon a recommendation from Midlothian Economic Development to approve a program and expenditure of up to \$8,000 related to a career center and outlined in the Economic Development Incentive Agreement with Navarro College
