2023-335 Conduct a public hearing regarding the proposed FY 2023-2024 tax rate, and schedule and announce the date, time and place of the meeting to adopt the tax rate.


2023-336 Consider and act upon an ordinance amending the Code of Ordinances by amending Chapter 11 Titled "Taxation" by amending Article 11.02 titled "Ad Valorem Taxes" by amending Division 2 titled "Exemptions" by amending Section 11.02.034 titled "General Residence Homestead Exemption – Granted" for the tax year beginning January 1, 2024 in the amount equal to twenty percent (20%) of the appraised value of the residence homestead with a minimum exemption of \$5,000.

2023-337 Consider and act upon an ordinance authorizing the issuance and sale of City of Midlothian, Texas, Tax Notes, Series 2023, in an aggregate principal amount not to exceed \$5,000,000 approving the sale of the notes; and ordaining other matters related thereto, including immediate effectiveness.

2023-338 Consider and act upon an ordinance, by record vote to adopt the FY 2023-2024 Annual Operating Budget and Plan for Municipal Services for the ensuing fiscal year beginning October 1, 2023 and ending September 30, 2024, in accordance with Local Government Code §102; appropriating money to a Sinking Fund to pay interest and principal on the City's indebtedness; appropriating the various amounts thereof; repealing conflicting ordinances and resolutions; including a severability clause and establishing an effective date

- 2023-339 Consider and take a separate vote to ratify a property tax revenue increase as reflected in the FY 2023-2024 Annual Operating Budget when compared to the FY 2022-2023 Annual Operating Budget; this budget will raise more total property taxes than last year's budget by \$6,389,757 which is a 17.04 percent increase from last year's budget and, of that amount, \$2,176,457 is tax revenue to be raised from new property added to the tax roll this year.
- 2023-340 Consider and act upon an ordinance, by record vote of the City Council of the City of Midlothian, Texas, levying and assessing municipal ad valorem taxes for the City of Midlothian, for the fiscal year 2023-2024, at \$0.329455 for Maintenance and Operations and \$0.320545 for Interest and Sinking Funds, for a total of \$0.650000, specifically for the purpose for which said taxes may be expended and directing the assessment and collection thereof; repealing conflicting ordinances and resolutions; including a severability clause and establishing an effective date.
