# 2023-413 ACTION RESULTING FROM EXECUTIVE SESSION, ITEM #2: REAL ESTATE

Mayor pro tem Wickliffe moved to authorize the City Manager to negotiate and execute an agreement with Joyce E. Houk to purchase (1) a 0.363 acre tract of land for street right-of-way and (2) a 0.031 acre tract of land for a permanent drainage easement, both located within the P.W. Lowe Survey, Abstract No. 661, City of Midlothian, Ellis County, Texas in consideration of a purchase price of \$15,473 in association with construction of the Mockingbird Lane Road Project, plus payment of all related closing costs. The City Manager is further authorized to execute on behalf of the City such additional closing documents as may be required by such agreement and the title company as necessary to close this transaction. Motion was seconded by Councilmember Gardner and carried unanimously (7-0).

Mayor pro tem Wickliffe moved to authorize the City Manager to negotiate and execute an amendment to the Purchase Sale Agreement between the City and MidTexas International Center Inc. effective September 14, 2022 to provide for the purchase of an additional 0.2 acres adjacent to the City's property for the purchase price of \$35,000.00, and to modify the location of the access easement described in said Purchase and Sale Agreement to provide for an access point to the Seller's property south of said 0.2 acres, and further authorize the City Manager to negotiate and execute all conveyance and other documents necessary for the closing of such purchase. Motion was seconded by Councilmember Hammonds and carried unanimously (7-0).
