Following discussion, Mayor pro tem Wickliffe moved to deny Item 2024-077 as presented with the condition that a Resolution be drafted in lieu of an ordinance. Motion failed by a vote of 2-5, with Mayor Coffman and Councilmembers Rodgers, Hammonds, Gardner and Hartson voting in opposition. Council moved into Executive Session under Section 551.071(2) for legal consultation at 9:00 p.m. Council reconvened into Regular Session at 9:08 p.m. with no action taken during Executive Session. Councilmember Gardner moved to approve Item 2024-077 as presented.
