- 2020-06 Conduct a public hearing and consider and act upon a request for an amendment to a Specific Use Permit on a 624 square foot portion of Lot 4BR1, Block 1, Midlothian Plaza Shopping Center Addition, Commonly known as 1111-B George Hopper Road, to allow for additional signage and restate the existing Specific Use Permit (Case No. SUP25-2019-181).
